In supersession of this Directorate's letter of even number dated 26.8.2002 on the above subject, it has now been decided in consultation with the Ministry of Health and Family Welfare that covered of the lone CGHS dispensary in Chandigarh will be restricted to 3 kms radius of the dispensary in Chandigarh and Mohali in respect of the serving Govt. employees. As a result the following sectors in Chandigarh and Mohali are covered:-

42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52
Industrial area-II (Ram Darbar).

Mohali: 62, 63, 64, 65
Phase- VIII, IX, X and XI.

2. The Central Govt. employees having their place of residence in the areas outside the covered area of the dispensary would get their medical cover under the CS(MA) Rules 1944.
