

Minutes of General Body Meeting of CGEWCC Chandigarh, held on 01.10.2019

Mr Balram Krishan, the Treasurer informed the house that the expenditure of committee is more than the funds received therefore we should try to increase our funds input.


IX) Agenda Item :Annual Subscription of CGOs
